

**Monitoring Expectations for Program Participants**

1. Participants will be told when they sign their Participation Agreement that there will be expectations for behaviour and follow-through in their programming. If they do not meet the Program Team's expectations, there will be some sort of consequence applied.
2. When Participants sign their Support Plan, it should be explained to them, once again, that the Program expects their Support Plan to be followed. If the Support Plan is not adhered to as agreed by the Participant, they can expect to be subject to consequences that can include but are not limited to: increased monitoring, Directed Projects, curfew/house arrest, bail revocation, requirement of guilty pleas (where applicable) and ultimately termination from the Program (see note below).
3. When the Program Team reviews the Participant's progress they should explicitly reference the Support Plan and evaluate whether the Participant is doing what they have agreed to do. This review of the Support Plan should include reference to attending community support meetings/programming, abstaining from substance use, attending Program meetings including court appearances, participation in appropriate structured activity, etc. The degree to which a Participant (within the limits of their current capabilities) is adhering to their Support Plan will be the basis upon which that individual is placed into one of the following levels. Depending on the level, the Program Team may need to intervene to recommend the appropriate next steps.

<b>Description</b>	The Participant is following the Support Plan and doing well. There is evidence of ongoing motivation and moderate participation. Motivation to participate is fair.	The Participant is failing to follow-through on most, or all the elements in the Support Plan. The Participant shows little/no motivation to be an active Participant in the Program, is evidencing more substantive issues around med compliance, substance abuse, ongoing criminal activity, meetings are missed regularly.
<b>Outcome</b>	On positive track to graduation and/or completion.	Continue with direct supervision and monitoring of Support Plan.	If regularly at this level, consider entering guilty pleas (where applicable) or removal from the Program.

Curfew or house arrest (Variation of Liberties)</li><li>8. Addition to SUS List (where applicable) and /or increased Testing.</li><li>9. Termination from the Program.</li></ol>

### **Substance Use Screening (SUS) List**

In determining whether a Participant will be required to be on the SUS List as a condition of their participation in the Court. The following will be discussed by the Team:

- whether substances were a key feature in the offence;
- whether the use is recreational or does it rise to the level of a substance use disorder;
- does the Participant have history of use connected with criminal offending; and
- does the use affect their mental stability?

Participants on the SUS List will be directed by the Dartmouth Wellness Court Probation Officer to report for testing. It will be random and consistent with the Testing Waiver.

Please note that all Opioid Court Program Participants will be on the SUS List throughout the entire duration of their participation in the Program.
