


**NOVA SCOTIA COURT OF APPEAL**  
**Civil Procedure Rule 91**

**The attached copies of RULE 91 (English) and RÈGLE 91 (Français) were made by the Judges of the Court of Appeal on December 31, 2008.**

**The following changes were made to the previous English version of Rule 91, dated June 6, 2008:**

1. **Rule 91.01** by:
  - a. adding the equivalent French word in parenthesis following each definition
  - b. deleting the hyphen in "Attorney General" in the definition of Attorney General
  - c. adding "section 2" in the definition of Attorney General
2. **Rule 91.03** by adding a hyphen to the word "non-compliance".
3. **Rules 91.05(2)(a), 91.11(1)(b), and 91.14(1)** by adding the words "whose judgment is being" after the word "court".
4. **Rule 91.05(2)(a)** by deleting the word "the" after the words "kind of".
5. **Rule 91.05(3)** by adding commas after the words "or" and "solicitor".
6. **Rules 91.06, 91.07, and 91.91.13** by substituting lower case letters in the second and third words of the headings.
7. **Rule 91.06** by deleting the comma after "82.08".
8. **Rule 91.09** by adding an "s" to the word "section".
9. **Rules 91.09, 91.11(3), 91.12(2), 91.18(1)(a) and 91.18(1)(b)** by substituting numerals for the words for numbers over 10.
10. **Rule 91.09(2)** by deleting the comma after "94.02".
11. **Rule 91.10(1)** by substituting "a" for "an" before the word "prisoner".
12. **Rule 91.11(3)** by substituting the word "was" for the word "is".
13. **Rule 91.14(2)** by deleting a comma after the word "appellant" in the first line and adding a comma after the first "General" in the second line.
14. **Rule 91.14(3)** by substituting the word "subsection" for "s."
15. **Rule 91.15(2)(b)(i) and (iii)(A)** by deleting the hyphen from the word "redirect".

16. **Rule 91.15(2)(b)(iii)(B)** by adding “the” before the word “transcript”.
17. **Rule 91.15(2)(b)(iii)(A) and (B)** by changing the semi-colons and the end of the subsections to commas.
18. **Rule 91.15(3)** by substituting the word “all” for the word “both”.
19. **Rule 91.15(3)(c)** by deleting the colon after the word “include”.
20. **Rule 91.15(3)(iii)** by deleting the word “and”.
21. **Rule 91.18(2)** by deleting the commas.
22. **Rule 91.18(3)** by capitalizing the words “Court” and “Appeal”.
23. **Rule 91.21(1)** by deleting the word “a” before the word “panel”.
24. **Rule 91.21(7), (8) and (9)** by adding “or panel of judges” after the word “judge”.
25. **Rule 91.24(2)(b)** by adding the word “that” after the words “ground of appeal”.
26. **Rule 91.24(3)(a),(b), and (c)** by changing the commas at the end of the subsections to semi-colons.
27. **Rule 91.24(3)(d)** by adding a comma after the word “record”, changing the comma to a semi-colon after the word “any”, and deleting the word “and”.
28. **Rule 91.25(1)** by substituting the word “who” for the word “that” in the first line.
29. **Rule 91.25(2)** by substituting the word “The” for “An”.
30. **Rule 91.25(4) and (5)** by substituting the word “and” for the word “or” after the word “exhibits”.




